

Spinoff Terms of Service

Spinoff Media Inc.

Effective Date: January 7, 2026

IMPORTANT: PLEASE READ THESE TERMS CAREFULLY. THEY CONTAIN A BINDING ARBITRATION AGREEMENT AND A CLASS ACTION WAIVER THAT AFFECT YOUR LEGAL RIGHTS.

1. Introduction

Welcome to Spinoff. Spinoff is a social platform that allows users to track television shows, rate content, share opinions, and engage in discussion with friends and the broader community.

These Terms of Service (“Terms”) govern your access to and use of Spinoff’s mobile applications, websites, and related services (collectively, the “Service”).

By creating an account, downloading the app, or otherwise using the Service, you agree to be bound by these Terms. If you do not agree, you must not use the Service.

If you are using the Service on behalf of a company or other legal entity, you represent and warrant that you have authority to bind that entity to these Terms.

These Terms constitute a legally binding agreement between you and Spinoff.

2. Eligibility and Age Requirements

You may use the Service only if all of the following conditions are met:

- You are at least 16 years old, or the minimum age of digital consent in your country, whichever is higher
- You have the legal capacity to enter into a binding agreement
- You are not prohibited from using the Service under applicable law
- You are located in a country where the Service is legally available

The Service is not intended for children under the age of 13. We do not knowingly collect personal information from children under 13. If we learn that a user is under 13, we may terminate the account and delete associated data as required by law.

If you are under 18 but above the applicable digital consent age, you may use the Service only with the consent and supervision of a parent or legal guardian. That adult is responsible for your use of the Service.

3. Accounts and Authentication

Certain features require you to create an account. You may register using third-party authentication providers such as Apple or Google.

By using third-party sign-in, you authorize us to receive information from those providers, such as your name, email address, and profile image, in accordance with our Privacy Policy.

You are responsible for:

- Maintaining the confidentiality of your login credentials
- All activity that occurs under your account
- Promptly notifying us at legal@spinoфф.community of any unauthorized access or security breach

We reserve the right to require verification of your account information and to suspend or restrict access if verification fails.

4. User Content

4.1 Definition

“User Content” includes all content you create, upload, post, submit, or share on or through the Service, including but not limited to:

- Reviews, comments, ratings, reactions
- Messages and lists
- Usernames, profile bios, profile images
- Any other material contributed by users

4.2 Ownership and License

You retain ownership of your User Content. However, by making User Content available on the Service, you grant Spinoфф a worldwide, non-exclusive, royalty-free, fully paid, transferable, and sublicensable license to use, host, store, reproduce, modify, adapt, translate, create derivative works from, distribute, publicly display, and publicly perform your User Content for the purpose of operating, improving, promoting, and marketing the Service.

This license continues for as long as your User Content is stored by us, including reasonable backup and archival copies, and subject to legal obligations.

4.3 User Responsibilities

You are solely responsible for your User Content and represent and warrant that:

- You own or have all necessary rights to your User Content

- Your User Content does not violate these Terms or any applicable law
- Your User Content does not infringe any third-party rights

4.4 Content Moderation

We have no obligation to monitor User Content. However, we reserve the right to remove, restrict, or disable access to any User Content at any time, with or without notice, for any reason, including legal compliance, safety, or policy enforcement.

5. Acceptable Use

You agree not to:

- Use the Service for unlawful purposes
- Post content that is abusive, harassing, defamatory, hateful, obscene, or otherwise objectionable
- Exploit, harm, or endanger minors
- Promote or depict self-harm, suicide, eating disorders, or serious violence
- Share sexual content involving minors or individuals appearing to be minors
- Violate intellectual property, privacy, or publicity rights
- Engage in fraud, scams, or misleading practices
- Send unauthorized advertising or spam
- Attempt to access accounts, systems, or data without authorization
- Introduce malware or harmful code
- Use bots, scrapers, or automated tools without permission
- Reverse engineer or decompile the Service except as permitted by law

Violation of this section may result in immediate suspension or termination.

6. Intellectual Property

All aspects of the Service, excluding User Content, are owned by Spinoff or its licensors and are protected by intellectual property laws.

You may not copy, modify, distribute, sell, lease, or exploit any part of the Service without prior written consent.

Spinoff is not affiliated with or endorsed by any television networks, streaming platforms, studios, or rights holders. All referenced media properties belong to their respective owners.

7. Third-Party Services

The Service may integrate with or link to third-party services. Your use of those services is governed

solely by their terms and policies.

We are not responsible for third-party services, content, availability, or practices.

8. Paid Features and Monetization

The Service may offer paid features, subscriptions, or premium content in the future.

Pricing, billing terms, and renewal information will be disclosed before purchase. Purchases made through app stores are governed by the store's terms and refund policies.

We may include affiliate links or sponsored content. We are not responsible for transactions or disputes with third parties.

9. Data Collection, Privacy, and Security

We collect and process personal data as described in our Privacy Policy, including:

- Account and profile information
- User-generated content
- Usage, analytics, and interaction data
- Device and technical information

We use reasonable technical and organizational measures to protect your data. However, no system is completely secure, and we do not guarantee absolute security.

To the maximum extent permitted by law, Spinoff is not liable for unauthorized access, data loss, or security breaches beyond our reasonable control.

You may have rights under data protection laws such as GDPR or CCPA. Requests may be submitted as described in our Privacy Policy.

OUR TOTAL LIABILITY FOR ANY CLAIM SHALL NOT EXCEED THE GREATER OF:

Any dispute arising out of or relating to these Terms or the Service shall be resolved through binding arbitration, not in court, except for small claims or injunctive relief.

You waive any right to participate in a class action, class arbitration, or representative proceeding.

17. Export Controls

You may not use the Service if you are located in a country subject to U.S. embargoes or are on a restricted party list.

18. International Use

You are responsible for compliance with local laws. We may restrict access in certain jurisdictions.

19. Changes to the Service and Terms

We may modify or discontinue the Service or these Terms at any time. Continued use after changes means acceptance.
